The Peralta Community College District Board of Trustees returns to the boardroom at 333 E. Eighth St. tonight at seven for its next-to-last regular meeting of the academic year.

Trustees will consider approval of a resolution in support of a November ballot measure that would extend Proposition 30, the 2012 state initiative that stabilized public education funding. They'll also look at accepting ductwork and fume-hood modifications at CoA as complete, part of ongoing Measure A expenditures.

Ferrilli, the consulting firm brought in after the IT management shakeup, will brief the board on its work, and PFT President Ed Jaramillo will offer public comments urging support of the Prop 30 resolution, advocating a speedy resolution to the current round of contract talks, and demanding improved access to up-to-date smart classrooms at Laney and around the district.

The board's final meeting of 2015-16 is set for Tues., May 10.
