

## <u>Peralta Federation of Teachers (PFT 1603)</u> Emergency Fund for Fall 2017 Fire Loss

#### **PURPOSE**

The PFT 1603 Grant Fund for Fall 2017 Fire Loss is available to provide a source of support/funding for current PFT Members who require temporary, immediate financial support due to evacuation from their homes as a result of the fires in Alameda/Napa/Santa Cruz/Sonoma/Solano Counties.

### **OVERVIEW**

Grants are for up to \$500 and can be used to reimburse losses incurred as a result of evacuation from a home in the fire area due to the fall fire of 2017. Receipts for the following items are acceptable (within the dates 9/26/2017-11/10/2017):

- Shelter during time of evacuation (i.e.: hotel costs, etc.)
- Replacement of essential personal belongings (clothing, shoes, etc.)
- Repairs for damage caused by fire or smoke

### **GRANT GUIDELINES**

- In order to receive funding, applicants must be faculty at one (or more) of the Peralta Community College District schools and current PFT 1603 members in good standing.
- Applications will be reviewed by the PFT Executive Committee on a case by case hasis
- Total grant funds available are limited to \$10,000 and emergency funds will be awarded on a "first-come, first-served" basis.
- Deadline for applications is December 1, 2017.
- In order to receive funding, faculty must have a home address through the Peralta District within an fire evacuation area (as defined by Cal Fire State of California Government office) from one of the following Fall, 2017 fires that occurred between 9/26/2017-10/25/2017:
  - ALAMEDA: Oakland Hills, Fallon
  - MENDOCINO: Redwood Valley
  - NAPA/SONOMA: Nuns, Adobe, Norrbom, Pressley, Patrick, Oakmont, Atlas
  - NAPA: Tubbs
  - SONOMA: 37, Pocket
- Upon final review by the PFT Executive Committee, the faculty member will be notified by email as to whether the grant was approved or denied.
- Funds (up to \$500) will be distributed via check to individuals with approved applications. Once the documentation is complete, it may take up to 2-weeks to receive a check.
- Incomplete applications will be returned.
